G. City Council to discuss and consider passing an ordinance establishing rules and regulations of the Emory Centre Shelter. Take any and all action necessary in this matter.

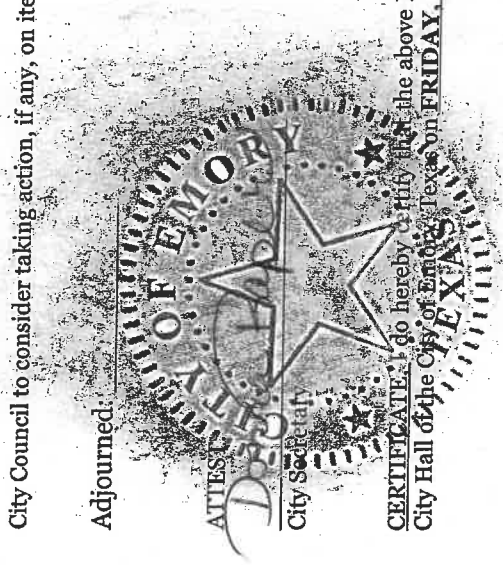
