Consent Agenda

Motion made by Blake Cooper, seconded by Travis Potts to approve the consent agenda, approving minutes from the July 20, 2021 City Council meeting, minutes of FY 2021-2022 Budget Workshop held on July 27, 2021, payments of the bills and approving the contract with ETCOG for the Inter-Local Contract for Data Maintenance (911 addressing). Motion carried unanimously.

- A. Departmental updates: Angie presented information on TxMyGov program. Director of EDC Robert Worley gave updated information on the 22 acres at 515/69, it had sold to a company which plans to build a convenience store, truck stop and a Whataburger on the land.
- B. Motion made by Emery Cathey, seconded by Travis Potts authorizing a contract between the City of Emory and Linebarger, Goggan Blair & Sampson, LLP., for fines and fees collection service. Motion carried unanimously.
- C. Motion made by Blake Cooper, seconded by Jannie Stephens to pass Resolution No. R9-2021 authorizing collection fee in the amount of 30%. Motion carried unanimously.
- D. No action needed on this item. Compliance of the A1024 Section 103 of the Housing and Urban development Act of 1968.
- E. Motion made by Blake Cooper, seconded by Jannie Stephens to pass Resolution No. R8-2021 adopting a negotiated settlement between the ATMOS Cities Steering Committee (ACSC) and ATMOS Energy Cor., Mid-Tex Division regarding the company's 2021 Rate Review Mechanism (RRM) Filing. Motion carried unanimously.


- F. Motion made by Blake Cooper, seconded by Emery Cathey approving Tax abatement Policy. Motion carried unanimously.
