# CITY OF EMORY MINUTES FOR PUBLIC HEARING and REGULAR CITY COUNCIL MEETING HELD ON JULY 8, 2025

# Public Hearing opened by Mayor Earl Hill III at 6:45 pm.

City of Emory held a public hearing to review, and to receive comments for a rezoning request from Leon Clark for the property located at 300 S. Texas St. (Airport/Hwy 19). Property Id No. 395 and 408 to change zoning from (R1) Single Family to (C1) Commercial. Planning and Zoning Chairman Landon Williams stated that the Planning and Zoning met on July 1, 2025, all members present, Chairman Landon Williams, stated that all members voted Yes, except Dennis Threadgill whom abstained to the zoning request change.

Motion made by Blake Cooper, seconded by Travis Potts approving the zoning change recommendation form the Planning and Zoning Commission from (R1) Single Family to (C1) Commercial for the property located at 300 South Texas St. (Airport / Hwy 19 South) (property ID No. 395 and 408). Motion carried unanimously.
- D, E, F, and G. No Action taken on adding Joel Kirkpatrick Accountant / Human Resource to the City of Emory Commercial Bank of Texas accounts, Tex Star and Logic investment accounts, Tex Pool investment accounts and the Edward Jones investment account.
- H. Motion made by Lori Honeycutt, seconded by Travis Potts appointing / hiring Chief Tom Parsons as Interim City Administrator. Motion carried unanimously.
